#### Investigators stay tight-lipped on Hopewell chemical plant probe

*(Richmond Times-Dispatch)*



Federal agents raided the AdvanSix chemical plant in Hopewell on Tuesday, with a spokeswoman for the company saying the swarm of police and environmental regulators stemmed from a federal search warrant. They have said next to nothing since.

"We can confirm that our people were there; beyond that we have no further comment at this time," said David Sternberg, a spokesman for the U.S. Environmental Protection Agency, on Friday.

#### Funds for Chesapeake Bay survive in federal spending bill

The spring snowstorm didn't stop Chesapeake Bay advocates from making their way to the nation's capital this week, where they warned members of Congress that many of the bay-restoration programs will be placed on ice if they don't get full funding.

It's the second year the Trump administration has proposed cutting federal funds for the Chesapeake Bay Program, a regional partnership between states to help restore the bay. This year's proposal would have cut the \$73 million budget by 90 percent.

But Chanté Coleman, director of the Choose Clean Water Coalition, says her group of about 200 members stormed Capitol Hill with success stories about the progress of the bay cleanup efforts - and it worked.

Virginia's ability to protect clean water has been expanded.


Governor Ralph Northam announced two bills from the Virginia Senate, SB698 and SB699, that establish processes for stop work orders on all or part of land-disturbing activities associated with national gas pipeline construction.

The Virginia Department of Environmental Quality would be able to issue such orders if it determines the activities caused or will imminently cause a substantial adverse impact to water quality.



(May 19, 2018)



Are you interested in learning more about your local stream? The Alliance for the Chesapeake Bay needs volunteers to collect important data on streams in Virginia. Through the River Trends program we will provide training and supplies. All you have to do is commit to attending a training and monitoring a site once a month.

You'll be analyzing water to collect data on core parameters such as dissolved oxygen, temperature, pH, water clarity and bacteria. All of these tests will be performed in the field using kits and equipment provided to you.
