Chesapeake Bay Foundation Find E Coli Pollution Up 100 Times State Standards At Richmond Recreation Spots

(The Community Idea Stations)



The Chesapeake Bay Foundation says after a heavy rainfall, bacteria levels at some of the Richmond area's more popular waterways can be up to 100 times higher than Virginia Standards for swimming and recreation.

The Foundation just concluded a pilot project to measure the levels of E Coli. Highest was at the Mouth of Gillies Creek, a popular fishing spot where the creek meets the James. CBF Executive Director Rebecca LePrell, says it is also nasty.

Citizens living in the Chesapeake Bay watershed who want to live and eat healthy while helping the health of the bay now have a handy online tool with which to better understand how individual lifestyle decisions cascade into the environment. A newly released "Bay Footprint" calculator - which focuses on nitrogen pollution - helps citizens to see how diet and other choices affect the bay's health, and how changed behaviors can improve the bay.
