### In the News

#### **Northam proposes \$733 million in environmental spending, with big chunk for Bay cleanup**

*(The Washington Post)*



Gov. Ralph Northam on Wednesday proposed a \$733 million package of environmental spending, including programs to clean up the Chesapeake Bay, encourage wind energy and preserve open spaces.

The proposals, most of which involve bond-financed capital spending, will be part of the two-year budget plan Northam (D) presents next Tuesday to legislators in the General Assembly's money committees.

"As sea levels continue to rise and flooding and extreme weather become more frequent and widespread, Virginia must act," Northam said in presenting his plan during an appearance in Virginia Beach.

The centerpiece of the package is \$400 million in proposed new funding to support cleanup of the Bay and meet the state's goals under federal guidelines to restore water health by 2025. That includes a boost to the state's Stormwater Local Assistance Fund to help with runoff issues in regions such as Hampton Roads.

### **Report says 4 of 6 Bay states cut funding, staff for top agencies handling pollution**

Four of 6 states in the Chesapeake Bay region cut funding or staff to their main pollution control agency over the last 10 years, says a report released today by the Environmental Integrity Project.

Environmental agencies in Pennsylvania, Delaware and New York each saw budget reductions, even after adjustments for inflation, between 2008 and 2018, according to the report, *The Thin Green Line: Cuts in State Pollution Control Agencies Threaten Public Health*. Those states, as well as Maryland, also reduced their environmental workforce during the same time period.

#### **Virginia's Environmental Endowment announces \$3.7 million in grants**

The Virginia Environmental Endowment is providing more than \$3.7 million in new grants to 22 partner organizations dedicated to advancing water quality and Chesapeake Bay improvements, land conservation practices, environmental literacy, climate resiliency, and invasive species control.

These awards - together with those announced last spring - bring the total VEE grants for calendar year 2019 to over \$4 million, which is the second highest yearly amount awarded in its 42 year history. The list of awards includes \$3.45 million in grants to seven partners to directly improve water quality in the James River.

#### **Mini Environmental Education Grant Program**

*(Chesapeake Bay Trust)*



Deadline to apply is 4pm on January 9, 2020.

Provides up to \$5,000 for projects that involve students investigating a local environmental issue, problem, or phenomenon through indoor and outdoor research culminating in developing solutions and taking action in their school or community - also known as the Meaningful Watershed Educational Experience (MWEE) model. Funds can cover costs for field trips, fieldwork, transportation, substitute fees, and supplies for student projects. This grant program also funds attendance to or development of professional development trainings for educators. Projects must be complete by September 1, 2020 due to NOAA funding source restrictions.
